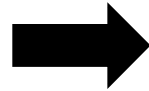

Filing and Service -

File the completed documents with the Clerk's Office...

There is no filing fee for this type of motion, as no change is being requested but simply enforcement of existing orders...

You must provide the other party with a copy of the Motion, which is indicated on the Certificate of Service. They do not need to be personally served – they just need to receive a copy...

Once the Court has reviewed all documents submitted, the Order will be issued and sent to all parties or you will receive notice of a court hearing to further address the issues...
