## CHIEF JUDGE ADMINISTRATIVE ORDER 2011-03 As amended 02-03-17

WHEREAS § 16-4-106, C.R.S. authorizes the use of a Pretrial Services program to assist the court in determining the amount of bail and type of bond by gathering and verifying information about defendants prior to the release of these individuals; and

WHEREAS pursuant to §16-4-106(3), C.R.S. a Pretrial Services program may be established pursuant to a plan formulated by a Community Advisory Board for such purpose and appointed by the Chief Judge of the 12th Judicial District; and

WHEREAS the Pretrial Services program shall establish procedures for the screening of persons detained due to an arrest as well as for the supervision of defendants who are released prior to trial:

WHEREAS the Pretrial Services program, Community Advisory Board and other judicial officials shall formulate procedures for setting conditions of bond of defendants ordered to the supervision of the Pretrial Services program prior to trial;

WHEREAS a Community Advisory Board has been in existence since 2011;

WHEREAS Alamosa County established a Pretrial Services program in 2011 but that program ceased operations in May 2016; and

WHEREAS Alamosa County now desires to re-establish a Pretrial Services program;

NOW THEREFORE, IT IS HEREBY ORDERED that the Community Advisory Board is reestablished and the following people are appointed (or re-appointed) to the board:

## **Required Members:**

District Attorney of the Twelfth Judicial District, currently Crista Newmyer-Olsen Managing Attorney, Colorado Public Defender Office in the 12<sup>th</sup>, currently Amanda Hopkins Alamosa County Sheriff, currently Robert Jackson

The Court also appoints:

Chief Probation Officer of the Twelfth Judicial District, currently Bill Gurule Pat Stanford, citizen member Alamosa County Commissioner, currently Helen Sigmond

The CAB shall be staffed by 12<sup>th</sup> Judicial District Court Administration Christina Gallegos, District Administrator.

THE CAB will review and recommend Standard Conditions of the Pretrial Services Program Supervision Agreement., which currently include the following provisions:

- 1. Appear in court when required or be subject to bond forfeiture and other criminal penalties. Report to the Pretrial Services Office after every court appearance and as Pretrial Services requires.
- 2. Do not violate any laws except minor traffic offenses.
- 3. Provide Pretrial Services with your current home address and phone number. Notify Pretrial Services within 24 hours if you change your residence and/or phone number.
- 4. Do not leave the State of Colorado without first obtaining the written consent of Pretrial Services, surety (if applicable) and the Court.
- 5. Contact Pretrial Services, as directed. Respond to phone calls and/or written correspondence from Pretrial Services within 24 hours or as instructed.
- 6. Allow Pretrial Services to make periodic visits to your home, which may include the presence of a peace officer.
- 7. Follow all conditions of any Mandatory Protection Orders that were issued by the Court.
- 8. If you are charged with driving under restraint because of a DUI, DWI, or excessive content, do not drive any motor vehicle.
- 9. If you have been arrested for a felony, you must sign a consent to extradition to Colorado and waive all procedures incidental to extradition if you are arrested in another state while on bond. You will not be admitted to bail in another state pending extradition to Colorado.

FURTHERMORE, that the Court, when determining the amount of bail, type of bond and in setting bond conditions of defendants under the supervision of a Pretrial Services program, may order such additional conditions as it determines in its discretion to be relevant, including, but not limited to:

- 1. [No Drugs] Do not use any controlled substances except for medications prescribed by a physician. Submit to and pay for random toxicology testing.
- 2. [No Alcohol] Do not consume alcohol; do participate in and pay for an alcohol-monitoring program.
- 3. [No Weapons] Do not possess or attempt to possess or control a firearm or other weapon.
- 4. [No Driving] Do not operate a motor vehicle (\_\_\_\_) under any circumstances (\_\_\_\_) without a valid license and required insurance.
- 5. [Employment] Seek or maintain employment. Notify Pretrial Services if employment begins or ends.
- 6. [No Contact] Have no direct or indirect contact with \_\_\_\_\_
- 7. [Electronic Monitoring] Participate in and pay for electronic monitoring.
- 8. [No Contact with Minors] Have no unsupervised visitation with children under the age of 18.
- 9. [Participate in Treatment] Participate in mental health, domestic violence and/or any other treatment/counseling services.
- 10. If you are on pretrial supervision for a DUI or DWAI and have a previous conviction of either, you must abstain from the use of alcohol and/or drugs and you must submit to the following alcohol/drug testing to monitor your abstinence: \_\_\_\_\_\_\_.

IT IS FURTHER ORDERED that the judges and courts of Alamosa County and the 12<sup>th</sup> Judicial District are authorized to use the Pretrial Services program to document all bond conditions ordered at the time of a defendant's initial bail hearing and monitor

compliance with all conditions of bond release for defendants ordered to pretrial services supervision.
